Florida's [2021 Reimagining Education and Career Help \(REACH\) Act](#) is a comprehensive blueprint for enhancing access, alignment and accountability across the state's workforce development system, which spans Florida's workforce, education and public assistance programs. With a focus on improved accountability, the law charges the Governor's REACH Office with developing criteria for determining letter grades for local workforce development boards. The law charges CareerSource Florida to assign letter grades to all local workforce development boards and publicly release them annually.

In November 2021, the REACH Office collaborated with a stakeholder group of experts, including leaders from CareerSource Florida, the Florida Department of Commerce (FloridaCommerce), the Florida Department of Education and local workforce development boards, to develop the letter grading system. Letter grades are calculated based on performance outcomes collected by FloridaCommerce, the Florida Department of Children and Families, and the Florida Department of Education. Through this interagency collaboration, preliminary letter grades were calculated for program year 2021-2022 (July 1, 2021, through June 30, 2022), for informational purposes only, using data and performance prior to the development of the methodology.

The CareerSource Florida Board of Directors was presented with a detailed overview of the methodology and metrics used to determine letter grades for each local workforce development board on September 12, 2022. These metrics include existing accountability measures for the federal workforce system along with new, statutorily defined measures focused on each local workforce development board's impact on the long-term self-sufficiency of participants. Additional measures capturing services to Florida businesses and upskilling of participants through training are also included.

Letter grades are assigned to local workforce development boards annually by October 15, following the close of the program year. Below are the letter grades by local workforce development board for program year 2022-2023. PY 2022-2023 Methodology

Developed by the Governor's Office of Reimagining Education and Career Help (REACH), the criteria for the letter grades are, in part, based on local board performance on accountability measures and return on investment, per [s. 14.36, Florida Statutes](#). As required by the [REACH Act](#), the majority of the grade is based on the improvement by each local workforce development board in the long-term self-sufficiency of participants through outcome measures such as reduction in long-term public assistance and the percentage of participants whose wages were higher after program completion compared to wages before participation in a program.

Targets

In consultation with CareerSource Florida and the Florida Department of Economic Opportunity, the REACH Office set the targets for each metric using historical performance data to test the letter grades methodology and the results were analyzed by an interagency workgroup. Adjustments will be made as needed to ensure fair, attainable goals with room for continuous improvement.

Metrics

Florida's letter grades for local workforce development boards include seven core metrics and one extra credit metric focused on employment services, training services, business services, and economic self-sufficiency. The metrics were developed with these [Guiding Principles](#) in collaboration with an interagency workgroup and feedback from local workforce development boards.

In the spirit of continuous improvement, these metrics are tracked and analyzed on a continuous basis and may be adjusted to reflect evolving economic conditions and state priorities.

<p>Extra Credit Metric: Serving Individuals on Public Assistance</p> <p>Local workforce development boards can earn up to an additional five percentage points for serving individuals on public assistance. Metric Calculations

As data becomes available, each metric is calculated as follows:

1. A rate is calculated using the metric's numerator and denominator.
2. The percentage of the target met is then calculated by dividing the rate by the metric's target and then capping it at 100 percent.
3. The percentage of the target met is then multiplied by the metric's weight to get the weighted performance.

The result of each step is rounded to the hundredth decimal place.

CALCULATION EXAMPLES

Example 1:

❶ $600 \text{ (numerator)} / 2,200 \text{ (denominator)} = 27.27\% \text{ (rate)}$

❷ $27.27\% \text{ (rate)} / .25 \text{ (25\% target)} = 109.08\%$
109.08% is then capped at 100% (percentage of target met)

❸ $100\% \text{ (percentage of target met)} \times .10 \text{ (weight)} = \mathbf{10.00\%}$ (weighted performance)

Example 2:

❶ $900 \text{ (numerator)} / 3,000 \text{ (denominator)} = 30.00\% \text{ (rate)}$

❷ $30.00\% \text{ (rate)} / .50 \text{ (50\% target)} = 60.00\% \text{ (percentage of target met)}$

❸ $60.00\% \text{ (percentage of target met)} \times .10 \text{ (weight)} = \mathbf{6.00\%}$ (weighted performance)

Grade Determination

Once each metric is calculated, the weighted performance (see #3 in the examples above) are summed for a final score that translates into a letter grade based on the following scale:

- A+: ≥ 97
- A: 93 to < 97
- A-: 90 to < 93
- B+: 87 to < 90
- B: 83 to < 87
- B-: 80 to < 83
- C+: 77 to < 80
- C: 73 to < 77
- C-: 70 to < 73
- D: 60 to < 70
- F: < 60
